

Case studies

Potentially meaningful impacts on investors' reputation and behaviour.



- Alleged to overstate ESG-integrated FUM
- Investigated by both BaFin and SEC
- CEO resigns after police raid HQ







- Reporting of exclusions allegedly inconsistent with Mercer Super holdings
- Current misconduct case in Federal Court
- First action of this kind by ASIC



Scrutiny rising on outsourced ESG assessors

- MSCI changed its ESG rating methodology – downgraded 31,000 exchange traded funds (ETFs).
- Regulators and investors are increasing their scrutiny on ESG ratings globally
 - Japan, UK, Europe.
